

6. Electronic bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs. on 2076/01/24 (7th May, 2019) at Rapti Sonari Rural Municipality Office Agaiya Banke. Bids must be valid for a period of 90 after bid opening and must be accompanied by a bid security of scanned copy of the bid security in pdf format, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
